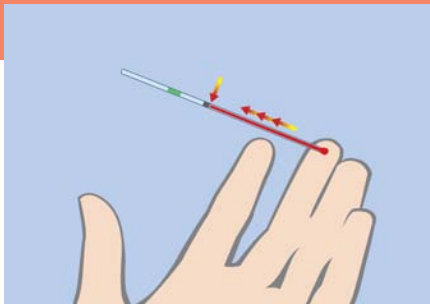

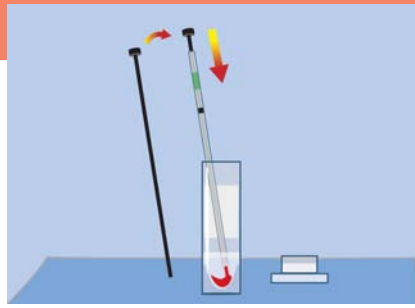

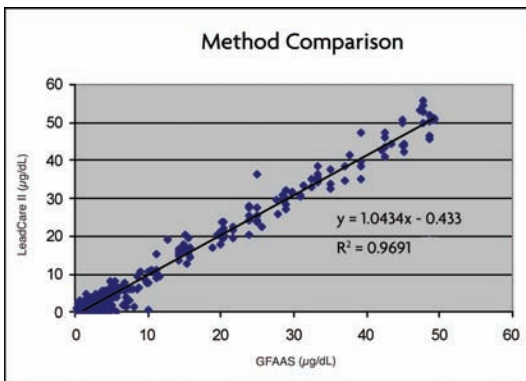

### Accurate

The accuracy of the LeadCare II system was determined by a method-comparison study in which 431 human samples (111 spiked with lead) were tested by untrained users at 11 different sites. These LeadCare II results were compared to a reference laboratory using graphite furnace atomic absorption spectroscopy (GFAAS).
